Merritt Parkway (CT-15) Northbound:

1. Take the Merritt Parkway (CT-15) North.
2. Take Exit No. 49 N, Route 25, toward "Danbury".
3. Merge onto the route 25 Connector.
4. Follow the Route 25 Connector for approximately 4 miles to the traffic light.
5. Continue straight on Route 25 for another 4 miles (passing three traffic lights into the "Clock Tower Square" Shopping Center on the left.
6. Turn left into the parking lot of Clock Tower Square.
7. Our office is to the right of the center, next to Tutor Time.

Merritt Parkway (CT-15) Southbound:

1. Take the Merritt Parkway (CT-15) South.
2. Take Exit No. 49 N, Route 25, toward "Danbury".
3. Merge onto the route 25 Connector.
4. Follow the Route 25 Connector for approximately 4 miles to the traffic light.
5. Continue straight on Route 25 for another 4 miles (passing three traffic lights into the "Clock Tower Square" Shopping Center on the left.
6. Turn left into the parking lot of Clock Tower Square.
7. Our office is to the right of the center, next to Tutor Time.

Interstate 95 (I-95) Northbound:

1. Take I-95 North
2. Take Exit No. 27A, Route 25/Route 8 Connector.
3. Merge onto the Route 25/Route 8 Connector.
4. Follow the Route 25 connector approximately 12.5 miles to the end of the highway coming to a traffic light at a four-way intersection (Route 25 & Route 111).
5. Continue straight on Route 25 for another 4 miles (passing three traffic lights into the "Clock Tower Square" Shopping Center on the left.
6. Turn left into the parking lot of Clock Tower Square.
7. Our office is to the right of the center, next to Tutor Time.

Interstate 95 (1-95) Southbound:

1. Take 1-95 South.
2. Take Exit No. 27 A, Route 25/Route 8 Connector.
3. Merge onto the Route 25/Route 8 Connector.
4. Follow the Route 25 Connector approximately 12.5 miles to the end of the highway coming to a Traffic Light at a Four-way Intersection (Route 25 & Route 111).
5. Continue straight on Route 25 for another 4 miles (passing three traffic lights into the "Clock Tower Square" Shopping Center on the left.
6. Turn left into the parking lot of Clock Tower Square.
7. Our office is to the right of the center, next to Tutor Time.

Interstate 84 (1-84) Westbound:

1. Take 1-84 West.
2. Take Exit No. 10, Route 6, toward "Newtown".
3. At the Bottom of the Exit, Take a Right.
4. Follow the Road to a Flagpole in the Center of the Road (Road Ends).
5. At the Flagpole, Take a Left around the Flagpole.
6. Follow Route 25 approximately 8 miles (passing the Sand Hill Plaza on the Right).
7. Turn right into the parking lot of Clock Tower Square.
8. Our office is to the right of the center, next to Tutor Time.

Interstate 84 (1-84) Eastbound:

1. Take 1-84 East.
2. Take Exit No. 10, Route 6, toward "Newtown".
3. At the Bottom of the Exit, Take a Left.
4. Follow the Road to a Flagpole in the Center of the Road (Road Ends).
5. At the Flagpole, Take a Left around the Flagpole.
6. Follow Route 25 approximately 8 miles (passing the Sand Hill Plaza on the Right).
7. Turn right into the parking lot of Clock Tower Square.
8. Our office is to the right of the center, next to Tutor Time.
